What is Workplace Giving?

Workplace Giving offers the opportunity for you to make a positive contribution to social justice. Through regular contributions, which are deducted automatically from your salary each pay period, you will be assisting Jesuit Social Services to advocate for social change and promote the health and wellbeing of disadvantaged young people, families and communities. Workplace Giving is a way to give back to the community and know that you are helping shape a better world.

Benefits for employees

- Championing social justice: your support will enable us to work in some of the most difficult and demanding areas in our community.
- Workplace Giving donations are deducted from pre-tax salaries, which means that your taxable income is reduced immediately without the need for receipts

Benefits for employers

Participating in Workplace Giving is a great way for companies to demonstrate their social responsibility by committing their business to long-term economic and social development of families and communities. This in turn sends positive signals to investors, shareholders, employees and customers alike. Employers can further support their employees' efforts by matching their donations - demonstrating an organisational commitment to staff interests.

How to set up Workplace Giving
